**Philosophy**

**Academic Standards**

**In accordance with the Athletic Department’s Philosophy, academic excellence is paramount for the student-athlete—each athlete must maintain a 2.50 gpa and a passing grade in each core subject (Bible, Math, English, Science, and History).** The first eligibility report of grades will be made after the first two weeks of the season. Thereafter, every Friday eligibility will be reported to the Athletic Director by the Administration for that week’s grading period. Any student-athlete who is found deficient in any subject area will be placed on a one-week probation from any sports-related activity. While on probation, the student-athlete may participate in practice and play in games. If after the one-week probation the student remains deficient, he/she will be removed from the team and not be permitted to participate in any practice or game for a period of two weeks. If the student is still deficient (or deficient in another class), he/she will be removed from the team for the remainder of the season. A student is only allowed one probation period per season. Thus, if they regain eligibility after their initial probation period, but become ineligible later in the season, they are immediately removed from the team, without probation. Once a student has been removed from a team, they will be ineligible for the remainder of that sport’s season, regardless of whether they improve their grades (subject to Administrator override).

Failure to abide by this contract is subject to disciplinary action by the Head Coach, Athletic Director or EFCA Administration.
